Whereas the Corporation of the City of Pembroke officially declared a climate emergency recognizing that climate change poses a worldwide threat, including localized threats to infrastructure, residents, businesses, institutions, investors, and developers within the City, on April 20th, 2021; and

Whereas Resolution 2021-012 committed the Corporation of the City of Pembroke to instruct staff to work with the Climate Action Advisory Committee to develop and present a Climate Action Plan which will identify work done and strategies implemented to date, review existing policies and plans, identify key partnerships and required resources, and determine appropriate strategies to achieve goals of sustainability, adaptability, and mitigation towards a net-zero carbon future for the City; and

Whereas the City of Pembroke committed to engage all staff and elected officials in building literacy and capacity on climate action; and

Whereas the City of Pembroke has begun to address climate change issues through the establishment of the Climate Action Advisory Committee, energy-saving measures undertaken by the Operations Department, and beginning a greenhouse gas inventory; and

Whereas the City will benefit from a systemic approach for assessing and addressing climate change issues if all Committees, Directors, and their relevant Departments consider climate change impacts, and mitigation and adaption strategies in their decisions and operations.

Therefore be it resolved that the Corporation of the City of Pembroke shall:

- Require consideration within each Committee and City Department of how their decisions and actions would contribute to or mitigate the effects of climate change, whether globally or locally; and
- Encourage and empower City Committees and City Departments to incorporate considerations for mitigation of and adaptation to climate change within their Committee or Department, and across the Corporation.

Further be it resolved that City Council forward this resolution to all Committee Chairpersons and Department Managers.
