a. PFD November Monthly Report

b. Supply & Delivery of Three (3) Current Year Pick-Up Trucks Mr. Lewis presented the report.

That the Finance & Administration Committee approve the award of the supply and delivery of three (3) current year pick-up trucks to Roy's Chevrolet Buick GMC Inc. in the amount of \$147,000 plus HST with the addition of standard safety equipment to each of the vehicles in the amount of \$4,530. The total value of the recommendations equal \$151,530.00 plus HST. And that the budget shortfall be funded from the COVID funding contingency/reserve.

c. Twinning of Townline Lift Station – Tender No. 2202-19072-01

Mr. Lewis presented the report. A discussion was held, and the following points were raised:

- Increase is due to COVID and its resulting supply chain issues
- This project needs to happen and the City needs to proceed as if the force main fails, the raw sewage from approximately 1,200 homes will run into the Muskrat River
- Intent is to have the project start in 6-8 weeks, run through until January/February 2023, with final restoration in the spring of 2023

The total value of the recommendations equal \$7,898,885.07 plus applicable HST.

 Project to the Townline Forcemain Twinning project; and
- Staff to transfer \$338,900 from the wastewater development charge fund to the Townline Forcemain Twinning project.
