4. New Business

a. PFD Monthly Report – December 2022

Chief Selle presented the December information report. A discussion was held, and the following points were raised:

- In response to a question, Chief Selle indicated that he preferred to continue presenting the monthly Pembroke Fire Department report in-person.
- A copy of the City's Emergency Plan notification process will be shared with Councillor Purcell

- In the event of a significant weather event, the Director of Operations or his designate send notifications using the City's media release email notification protocol.
- In the event of a major fire, the Fire Chief notifies Council after the fire is brought under control.
- b. Partnership with County of Renfrew for Flood Hazard Identification and Mapping Funding Application

Chief Selle presented the report. A discussion was held, and the following points were raised:

- Important to join with the County for this mapping project.
- The information gained will be very valuable and is required for planning processes.
- c. Riverside Park Pumping Station Upgrades Request for Tender No. 21-2045A Mr. Unrau presented the report.

d. 2022 Municipal Election Accessibility Report

Ms. Martin reviewed the information report. In response to a question, it was noted that telephone voting was not offered in 2022 as in previous elections, only 8% of the electors used this voting method and a large number of complaints were received due to its cumbersome use.

e. 2022 Election Report

Ms. Martin presented the information report. A discussion was held, and the following points were noted:

- On-line voting and voting tabulators are very efficient and any issues that occurred were dealt with quickly and efficiently.
- Internet voting offers a 10-day 24/7 voting period.
- The Pembroke Public Library as well as City Hall offered eligible electors the use of computers to enable them to cast their vote.
- f. Council/Staff Relations Policy

Mr. Unrau presented the report for Committee consideration. A discussion was held, and the following points were raised:

- In conjunction with the City's Disconnect from the Workplace Policy, the Council/Staff Relations Policy should reflect that emails can be sent to staff during off-hours however staff are not expected to respond until the following working day
- If Council members have been made aware of a health and safety concern, they should direct that concern to the after-hours number for immediate action.
