Resolution 2023-007 – Resolution of Support to Extend Funding for RC VTAC

Whereas the Renfrew County Virtual Triage and Assessment Centre (RC VTAC) has been operating since March 2020, providing residents of the County of Renfrew, including the City of Pembroke, with an invaluable medical response option for our residents, many of whom are without a regular primary care physician; and

Whereas RC VTAC has, since its inception, provided over 73,000 family physician virtual assessments, over 69,000 paramedic on-site assessments, and over 5,500 paramedic home visits; and

Whereas every month, RC VTAC currently handles 5,000 calls, 3,000 assessments and 1,000 avoidable emergency department visits; and

Whereas 86% of RC VTAC users have reported that their health care concern was dealt with at their first virtual encounter; and

Whereas 93% of RC VTAC users have reported being happy or very happy with the service; and

Whereas funding from the Government of Ontario for RC VTAC is scheduled to conclude in March 2023.

Now Therefore the Council of the Corporation of the City of Pembroke resolves as follows:

- 1. That the City of Pembroke does fully and strongly support the Renfrew County Virtual Triage and Assessment Centre as a valuable and innovative tool for providing medical care to local residents, many of whom do not have a primary care physician;
- 2. That the City of Pembroke does recognize that the Renfrew County Virtual Triage and Assessment Centre provides an effective and efficient medical care option that helps relieve stress on our local emergency departments;
- 3. That the City of Pembroke supports in-home delivery of medical services, when possible, to support our stay-at-home senior population as well as residents with disabilities or mobility issues:
- 4. That the City of Pembroke believes the Renfrew County Virtual Triage and Assessment Centre to be a proven model for the delivery of certain non-emergent health care needs as one part of our overall health care system;
- That the City of Pembroke does now strongly call upon the Government of Ontario to continue funding the Renfrew County Virtual Triage and Assessment Centre as a permanent health care option for residents in the City of Pembroke and the County of Renfrew; and
- 6. That the City of Pembroke forward a copy of this Resolution to the Hon. Sylvia Jones, Deputy Premier & Minister of Health; Mr. John Yakabuski, Member of Provincial Parliament (Renfrew~Nipissing~Pembroke); and Mr. Peter Emon, Warden of the County of Renfrew.

Mayor Gervais stated that he attended The Grind's Coldest Night of the Year event held on February 25, 2023, which raised more than \$105,000. On March 2nd, he attended an Algonquin College Pembroke Campus and Private student Residence tour and noted the great relationship between private developers providing residences and the college.

Deputy Mayor Abdallah indicated that he attended the very successful PBIA Soupfest held on March 4, 2023. He mentioned that the Pembroke Community Garden will be hosting another rain barrel fundraiser at the end of March. Deputy Mayor Abdallah mentioned that a job fair will be held on March 27th from 1:00 p.m. – 4:00 p.m. at the Pembroke Campus of Algonquin College. The next Community Watch meeting will be held on April 3rd at the Pembroke Fire Hall.

Councillor Lafreniere stated that the Civic Awards will be taking place again this year on Monday, June 5th. She mentioned that there are separate awards for youth as well as the Civic awards.

Councillor Kuehl thanked all the organizers of the successful Soupfest event and noted that the Pembroke Farmer's Market location provides an excellent venue especially during the winter months. Councillor Kuehl also listed the upcoming events being held at Festival Hall during the month of March.

Councillor Purcell stated that the Renfrew County and District Health Unit (RCDHU) recently announced that Dr. Jason Morgenstern will be new Medical Officer of Health and welcomed him back to the Valley. He also mentioned that the RCDHU services in Renfrew will be relocating to 127 Raglan Street at the end of June 2023.
