6. New Business

a. PFD Monthly Report – May 2023

Chief Selle presented the information report. A discussion was held and the following points were raised:

- Congratulations to the two firefighters Dunn and Gibbon for receiving the Firefighter of the Month award, and to Dereck Beaupre for receiving the Volunteer of the Month award
- Pet notification stickers can be obtained from the Fire Department and the OSPCA
- b. By-law to Regulate Recreational Open-Air Burning

Chief Selle presented the report. A discussion was held, and the following points were raised:

- Need a well-regulated by-law offered to more residents with specific standards to be met
- Keep in mind that we are an urban municipality
- Perhaps a permanent location for a ceremonial fire pit may be an option
- Public consultation may be a good idea
- Fire Chief should review case by case with permit system
- Come back with a by-law meeting specific standards with a permit system
- 5 metre minimum setback a good idea with current permit holders grandfathered in
- Backyard fires rarely create out of control fires
- No day burning may be a restriction
- High fine during burn ban should be enforced
- Promote recreational fire pits at Riverside Park
- Fuel types need to be addressed in the by-law
- Increased noise complaints could be a result
- Look into other devices ie smokeless fire rings
- Proper base should be required
- Windspeed at 25 km/h cap
- Pilot project would be a good idea
- Current burn ban in effect

Staff Direction:

Committee directed staff to bring back options regarding opening up the permit process to include all properties that meet specific standards, and engage the public in consultation.
