# 7. Mayor's Report

Mayor Gervais stated that on June 13<sup>th</sup>, he was at Marianhill for the announcement by Minister Calandra and MPP John Yakabuski regarding the expansion of an additional 29 beds being added to the facility. On June 16<sup>th</sup>, the Mayor and the CAO met with the Pembroke Regional Hospital's CEO for a tour of the facility. Mayor Gervais sombrely mentioned that an accident happed early today involving a Chinook Helicopter with two members having been found and two missing. He indicated that out thoughts and prayers are with the members involved and their families. Due to the helicopter crashing into the Ottawa River, the Town of Petawawa stopped intake of water for treatment and the City of Pembroke has been providing water to the Town. He asked that all residents limit water usage as much as possible until further notice and that there is no threat to our drinking water quality.

# 9. Councillor Updates

Deputy Mayor Abdallah indicated that the public washroom on the west side of the Pembroke Waterfront Park and the new garden shed were vandalized. The graffiti was removed however the Vandals returned and vandalized the area again. Deputy Mayor Abdallah mentioned that the PBIA Youth Pop-up market will be held on Thursdays at Shamrock Park during July and August from 12 to 2 p.m. and if interested, contact the PBIA. This Thursday is the Grand Opening of the Visitor Information Centre located inside the Phoenix Centre. He thanked the sponsors for the PBIA Community Art Walk. The next meeting of the Youth Advisory Council will be held in September. The PBIA created an Eatery Guide which is now available throughout the downtown area.

Councillor Kuehl indicated that his thoughts are with the members of the 450 Squadron. On June 15<sup>th</sup> he attended the PBIA Shop Hop which showcased the downtown area. He also listed the upcoming events held at Festival Hall.

Councillor Jacyno stated that construction of the new RC Housing Authority 10 unit building at the Corner of Douglas/Lee Street is underway. Councillor Jacyno asked on behalf of Pembroke Heritage Murals, that the public be vigilant and report any suspicious activities to the OPP.

Councillor Purcell indicated that the Multicultural Festival is July 14 and July 15 at the Pembroke Waterfront Park, and they are still looking for sponsors. The Pembroke Multicultural Festival won the 2023 Event of the Year award from the Ottawa Valley Tourist Association. He also mentioned that there are still opportunities to register for the TD Summer Reading Program and contact the Pembroke Public Library if interested.
