Youth Council met in June with the next meeting on September 26th. He attended an online affordable housing meeting with Councillor Lafreniere. PBIA hosts a youth market Thursdays at Shamrock Park. Summer Sounds is every Saturday at Shamrock Park from 11:00 a.m. – 2:00 p.m.. He and Councillor Purcell are preparing for the 8th Annual Multicultural Festival this weekend beginning July 14th.

Councillor Kuehl thanked the Mayor for attending the Waterfront Media event. He thanked Fred Blackstein for his invaluable help at the Waterfront. He attended the National Indigenous Peoples Day. He attended the Strawberry Social. He commended Parks and Recreation staff for the wonderful events on Canada Day. Festival Hall has a Bruce Springstein tribute upcoming July 21st.

Councillor Lafreniere stated that while walking at the waterfront and saw graffiti on the path that had a beautiful message. She mentioned the Youth Triade Expo which is coming up Aug 26th.
