Whereas best practices for Ontario municipal government recommend the implementation of indemnification coverage for elected officials; and

Whereas indemnification coverage serves to attract qualified candidates for elected positions and promotes effective governance; and

Whereas many municipalities in Ontario have already implemented indemnification coverage for their elected officials; and

Whereas the City of Pembroke aims to align with the best practices prevalent in Ontario municipal government.

Therefore, Be It Resolved That the City of Pembroke shall implement indemnification coverage for all councillors, Deputy Mayor, and Mayor; and

Be It Further Resolved That the indemnification policy shall be reviewed and approved by City Council within 60 days of this motions' passing.

He thanked Karthi Rajamani, the Pembroke Public Library Board, the library staff and countless volunteers for their hard work and dedication to creating an amazing Multicultural Festival which was held on July 14 and 15, 2023. On July 27th he met with the owners of a Special Time to wish them well with their retirement. On the same day, he was able to participate in the opening of the great innovation Community Art walk. On July 29th he had the pleasure to conduct foot patrol with the Detachment Commander Stephan

Neufeld. Mayor Gervais reminded everyone of the annual Kids and Cops Fishing Derby which is being held on August 12th from 9 to noon at the Pembroke Waterfront Park.

10. Councillor Updates

Councillor Kuehl indicated that the recent Multicultural festival was a fantastic event. He attended and encouraged everyone to attend the Youth Pop-Up Market which is held every Thursday in July and August in Shamrock Park. He also attended the PBIA community art walk and thanked Council on behalf of the Robbie Dean Centre for their support of the Music for a Cause event which raised money for the organization. He thanked the Pembroke Fire Department and the Pembroke Professional Firefighters Association for the great fireworks display held on August 5th. Councillor Kuehl met with Member of Parliament Naqvi and together they toured the Renfrew County VTAC facility and met with residents on Moffat Street.

Councillor Jacyno stated that the longest free-standing mural in Canada "The Pioneers of Pembroke Township 1820-1850" has been restored and has been installed at the Upper Ottawa Valley Heritage Centre. He thanked Pam Dempsey and her committee for their hard work.

Councillor Lafreniere indicated that the Youth Try It Expo will be held on August 26^{th} from 10 a.m. – 2 p.m. at the PMC. She also encouraged local developers to participate in the CMHC Housing Solutions presentation via Zoom being held on August 29^{th} at 10:30 a.m.

Councillor Plummer provided an update from the Ottawa River Power Corporation and thanked all staff for their hard work to get the power restored after the many storm events beginning with the ice storm on April 5th.

Deputy Mayor Abdallah encouraged developers who are interested in joining the CMHC Housing Solutions presentation to contact him for the zoom link. He stated that the Police Services Board approved a new Community Watch in the downtown area as well as the Johnston Meadows area. He indicated that 25 years ago tonight, the idea of the Pembroke Waterfront Park was discussed and which has resulted in a wonderful park enjoyed by many.
