Mayor Gervais asked everyone to be mindful of flu and COVID and do their part to reduce the risk. On September 6th, the Mayor and Councillor Purcell were invited to attend the ribbon cutting ceremony of CNL's new Business Collaboration Centre. On September 8th Mayor Gervais attending the grand opening of Valley Hair Artestry. On September 17th he attended the start of Legion week who have events planned throughout the week. On the same day he had the great pleasure to attend the Pembroke Lumber Kings home opener against the Smith Falls Bears and encouraged everyone to attend the next game and take in some great hockey. Mayor Gervais indicated that he and Mayor Sidney (Town of Renfrew) have entered into another Battle of the Valley challenge between the Wolves and the Kings. Whichever team prevails will see the other teams Mayor and Deputy/Reave wear the opponent's jersey at a Council meeting. He advised that Jacqueline Parson has commenced her role as the Upper Ottawa Valley OPP Victim Specialist.
