5. Business Arising from Minutes

6. New Business

a. Parking Fees and Fines Report

Ms. Sauriol presented the report and requested direction on the amount of the fine for parking at an expired meter. A discussion was held, and the following points were raised:

- Council has to make a decision on what's best for the City taking into consideration staff time, parking lot maintenance, snow removal, printing tickets, etc.
- Parking generates an approximate \$90,000 deficit per year.
- Is a \$10 ticket really worth the cost of processing a fine?
- Appreciate that the downtown is not having the easiest time however they also need to recognize that the City has to cover its costs so deficits don't end up on the backs of other taxpayers
- Perhaps we should look at an incremental increase over the next few years i.e. \$15 this year and increase it again next year.
- Fines haven't changed in over 20 years.
- Meters keep traffic moving.
- Don't appreciate the negativity of the downtown merchants as Council has supported and continues to support downtown merchants.
- Council doesn't subsidize parking for any other business like we do for the downtown area.

- City Hall, Victoria Hall and the Pembroke Public Library are all classified as Heritage Buildings.
