#### a. Z-1-2024 – 163 Peter Street – Jason Turcotte

Mayor Gervais advised that the meeting was called to consider the application under the City of Pembroke Zoning By-law 2020-05, to rezone the property municipally known as 163 Peter Street from a "Residential Type 1 – R1" zone to a "Residential Type 3-45 – R3-45" zone".

The Clerk advised that notice was given by mail to all owners of property within a 120 m radius of the subject land, and was posted on the site, on February 5, 2024.

Mayor Gervais asked the City's Planner to review the report regarding the application. Mr. Hutton reviewed the report.

Mayor Gervais asked if there was any opposition to the application. Mr. Hutton indicated that no inquiries or written submissions have been received.

Mayor Gervais asked if there was any support for the application. Mr. Hutton indicated that the applicant, Mr. Jason Turcotte was present to support his application. Mr. Turcotte indicated that he will be adding 3 luxury apartments to the back of the dwelling which should be a nice addition to the City.

Councillor Kuehl indicated that members of the Planning Advisory Adjustment Committee were supportive of this application and are looking forward to seeing the extra rental units in the City to help meet supply and demand.

### b. Z-2/2024 – 240 Mackay Street – Jason Turcotte

Mayor Gervais advised that the meeting was called to consider the application under the City of Pembroke Official Plan, 2016, to redesignate the property municipally known as 240 Mackay Street from a "Central Commercial" designation to a "Residential" designation, and further, under the City of Pembroke Zoning By-law 2020-05 to rezone said property from a "Central Commercial-slope stability – C3-s" zone to a "Residential Type 3-46-slope stability – R3-46-s zone.

The Clerk advised that notice was given by mail to all owners of property within a 120 m radius of the subject land, and was posted on the site, on February 5, 2024.

Mayor Gervais asked the City's Planner to review the report regarding the application. Mr. Hutton reviewed the report.

Mayor Gervais asked if there was any opposition to the application. Mr. Hutton indicated that the department received one informational concern regarding the ingress/egress to the property.

Mayor Gervais asked if there was any support for the application. Mr. Hutton stated that Mr. Jason Turcotte, applicant was present at the meeting to support his application. Mr. Turcotte indicated that the building is in rough shape right now but once finished will have an updated look.

Mayor Gervais asked for a report from the Vice Chair of the Planning and Development Committee of Council. Councillor Kuehl indicated that the members of the Planning Advisory and Adjustment Committee had some questions which received satisfactory answers therefore there were no issues with this application.

Councillor Jacyno asked what type of rental units these new units will be to which Mr. Turcotte responded that the top units will probably be targeted to the 50+ age renter and the bottom units will probably be targeted to professionals.
