FINANCIAL REPORT:

BUSINESS ARISING:

Primary M&R:

'Canadian Armed Forces-At The Ready'

We are in possession of a waiver prepared by Bob Sheppard the City's Solicitor. Discussed Pam preparing a letter for Mr. Bell and attaching the blank waiver and Intact Insurance document asking if he will accept the waiver. Dennis & Claudia agreed. It will be sent this month.

"The Timber Raft':

The removal of the panels & structure went quickly, started on October 16th & finished on October 24th. A week ahead of Mr. McLean's request. Pam had one of the original screw nails that had rotted to almost nothing: Bryan Walsh said they had a difficult time removing some panels. Bryan & Matt have already got plans to replace the structure in the spring. It will have a wider cap than before and will be raised somewhat higher than the first structure.

Pam:

We will need to find/borrow four castor wheels and a piece of wood to create another dolly. Asking Committee to keep this in mind: the dolly can be dismantled afterwards.

We will borrow crates like we did before to raise the panels off the floor.

We do have sufficient Gorilla Glue and wide tape to repair corners etc.

We will borrow clamps as before and will need quarter inch hardwood again.

The Committee will do the repairs themselves.

We have enough paint & supplies for this work but will have to buy the clear coat product.

Pam has been in touch with Dean Burchart regarding a suitable space to use. It's possible Mr. Devine will have space for us, a charitable receipt in lieu of rent as before.

Pam suggested we use the fee paid to Karole Marois for the 'Pioneers of Pembroke Township' work as a guide for the artist's fee on this work.

Minor M&R:

None to report.

Dennis, Jane & Pam took paints & supplies to storage on October 27th. While there we took a look at this model and discussed where we could donate it. Jane & Dennis said it really belongs at the Heritage Centre and offered to make a formal offer.
